#### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$157,771 as of 12/31/2022, compared to \$52,593 as of 01/01/2022. During the plan year the plan experienced an increase in its net assets of \$105,178. During the plan year, the plan had total income of \$3,939,458

including employer contributions of \$1,470,488 , employee contributions of \$1,774,984 stop loss reimbursements of \$693,212 and earnings from investments of \$774.

Plan expenses were \$3,834,280. These expenses included \$250,678 in administrative expenses, \$2,784,588 in benefits paid to participants and beneficiaries, and \$799,014 in insurance premiums .
